4	This Act may be cited as the "Disaster Equity and

- 15 "SEC. 431. STATE AND LOCAL PLANS FOR MEAL DELIVERY.
- 16 "(a) IN GENERAL.—The Administrator may provide
- 17 assistance to a State, local government, or Indian tribal
- 18 government to reimburse the cost of coordinating food de-
- 19 livery, production, and distribution in the event of a major
- 20 disaster, including—
- 21 "(1) establishing a network to coordinate food
- delivery, production, and distribution with businesses
- and private nonprofit organizations;

11	tribution in the event of an emergency or major disaster
