6 (a) Transfer of Administrative Jurisdic-7 tion.—

8 (1) NATIONAL FOREST SYSTEM LAND.—Admin9 istrative jurisdiction over the approximately 160
10 acres of National Forest System land more particu-

larly described as T.1 S., R.19 E., sec. 1 24,2 SE<sup>1</sup>/<sub>4</sub>NE<sup>1</sup>/<sub>4</sub>, NW<sup>1</sup>/<sub>4</sub>SE<sup>1</sup>/<sub>4</sub>, NE<sup>1</sup>/<sub>4</sub>SE<sup>1</sup>/<sub>4</sub>, and 3  $SE^{1/4}SE^{1/4}$ . Mount Diablo Meridian, Tuolumne 4 County, California, as generally depicted on the map 5 entitled "Ackerson Meadow Land Interchange" and 6 dated February 24, 2022, is transferred to the Sec-7 retary of the Interior to be managed as part of Yo-8 semite National Park, in accordance with laws appli-9 cable to the National Park System.

10 (2) NATIONAL PARK SYSTEM LAND.—Adminis-11 trative jurisdiction over the approximately 170 acres 12 of National Park System land more particularly de-13 scribed as the  $SE^{1/4}$  of sec. 23 and the land to the 14 of Road 1S25within north and west the 15 NW<sup>1</sup>/<sub>4</sub>SE<sup>1</sup>/<sub>4</sub>NW<sup>1</sup>/<sub>4</sub> of sec. 24, T.1 S., R. 19 E., 16 Mount Diablo Meridian, Tuolumne County, Cali-17 fornia, as generally depicted on the map entitled 18 "Ackerson Meadow Land Interchange" and dated 19 February 24, 2022, is transferred to the Secretary 20 to be managed as part of Stanislaus National Forest 21 in accordance with laws applicable to the National 22 Forest System.

23 (b) CORRECTIONS.—

24 (1) MINOR ADJUSTMENTS.—The Secretary and
25 the Secretary of the Interior may, by mutual agree-

1	ment, make minor corrections and adjustments to
2	the Federal land transferred under subsection (a) to
3	facilitate land management, including making a cor-
4	rection or adjustment to any applicable survey.
5	(2) Publications.—Any correction or adjust-
6	ment made under paragraph (1) shall be effective on
7	the date of publication of a notice of the correction
8	or adjustment in the Federal Register.
9	(c) HAZARDOUS SUBSTANCES.—
10	(1) NOTICE.—The Secretary and the Secretary
11	of the Interior shall, with respect to the land de-
12	scribed in paragraphs (1) and (2) of subsection (a),
13	respectively—
14	(A) identify any known sites containing
15	hazardous substances; and
16	(B) provide to the head of the Federal
17	agency to which the land is being transferred
18	under subsection (a) notice of any site con-
19	taining hazardous substances, as identified
20	under subparagraph (A).
21	(2) CLEANUP OBLIGATIONS.—To the same ex-
22	tent as on the day before the date of enactment of
23	this Act, with respect to any Federal liability—

1	(A) the Secretary shall remain responsible
2	for any cleanup of hazardous substances on the
3	Federal land described in subsection $(a)(1)$ ; and
4	(B) the Secretary of the Interior shall re-
5	main responsible for any cleanup of hazardous
6	substances on the Federal land described in
7	subsection $(a)(2)$ .
8	(d) Effect on Existing Rights and Authoriza-
9	TIONS.—Nothing in this section affects—
10	(1) any valid existing rights; or
11	(2) the validity or terms and conditions of any
12	existing withdrawal, right-of-way, easement, lease, li-
13	cense, or permit on the land to which administrative
14	jurisdiction is transferred under this section, except
15	that beginning on the date of enactment of this Act,
16	the head of the agency to which administrative juris-
17	diction over the land is transferred shall be respon-
18	sible for administering the interests or authoriza-
19	tions in accordance with applicable law.
